8. Blood test is required every six month, if any diseases can be cure.
9. All care taker should maintain food and water properly. Also shed, grass Godown should be clean.
10. Training is must those who are taking care of Gau mata.

- Only on tube well is there it is only drinkable water are there so this tube well is provide water to 2800 cows and 60 employees are there and it is god gifted only.
- During the rainy seasons the cow and employee can not go out of campus therefore they have to store for cows fodders and staffs also.
