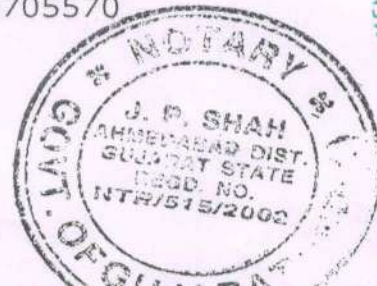

1. This Trust Deed is made to establish a public charitable trust. We, the settler hereby declare under our signature that, a Trust with non-revocable public charitable objectives will be formed with this Trust Deed.



2. The settler of this trust deed Ganpatbhai Maganlal Patel has donated Rs 1,001=00 Rupees One Thousand One only to this trust from his own earned income. No right of his heirs, assigners of him will be there on this income henceforth and this will be treated as Trust Property. The parties to the second part have accepted this as trust property and put their acceptance signatures hereunder.

3. With formation of this trust deed, the name of the trust, objectives and methods to appoint subsequent trustees, the management to achieve the objectives of the trust are enumerated herein below:

- (A) Name of the Trust: Menajivi Gaushala Charitable Sansthan-Ahmedabad
- (B) Working Territory of the Trust: Will domain in entire India
- (c) Address of the Organisation: 402, Akruti Complex, Near Sahyadri Flat, Stadium Circle, Navrangpura, Ahmedabad

#### 4. Objectives:

- (1) With this Trust spread the public awareness regarding cow protection and to work for development of intellectual, ethical, physical values as regards to importance of cow in the society.
- (2) To establish cowshed and to maintain the same and with that to serve cow and other animals.
- (3) To arrange cattle fodder, forage for cow, seeds for Birds water, medicines etc.
- (4) To shelter wandering, unaccounted, donated animals in the cowshed.
- (5) To provide fodder to the animals at the time of Natural calamities like flood, drought. To provide or arrange to provide, fodder, medicines and cattle for the speechless animals like cow, buffalo within the limits of the trust.
- (6) To do all the activities for protection of cow. Upkeep and nourish cows which are either rescued by the cow protectors or which are gifted individually.
- (7) To take land at a token rent from the persons for the fodder of cow and take it as donation. To take land as donation from persons, organisations, villagers for the green fodder of cow.



- (8) To organize and arrange for knowledge camps, speeches, sermons and camps for propaganda and dissemination of knowledge relating to cow protection. So as to protect the mother cow and make public understand about the mother cow.
- (9) To organize or make others organize knowledge camps, speeches, sermons and camps for propaganda and dissemination of knowledge.
- (10) To establish, run and maintain sports clubs and health clubs to promote sports activities. To own and teach scientific methods of using the latest equipment of sports for physical development, to take it as donation.
- (11) To build or arrange to build halls, dharmashala, wells, water plough, animal hospitals etc.
- (12) To guide and spread awareness amongst young boys and girls as regards to mis customs, of the society, addictions etc. and to rehabilitate and recover them from such addictions.
- (13) To establish, run and to maintain Clinics, hospitals, nursing homes, consulting rooms, laboratories, health centers etc. for the maintenance of the public health at large and for the people of the society and to help such services and to promote the same. To provide Ambulance van facility to the people within the limits of the trust.





- (14) To help the victims of Natural calamities like fire, flood, earthquake, drought and to do all the activities within preview and as part of duty without discrimination.
- (15) To help the victims of Natural or manmade calamities like pandemic, flood, earthquake, riots, cyclone, tsunami, fire, heavy rain, drought or at the time of war without any discrimination. To help the people who are victims of acute life harms and to provide them grains, cloths, medicines and all lifesaving items.
- (16) To undertake the activities of tree plantation, to protect trees, to plant trees, and to grow them, to undertake activities to advice, suggest and to undertake related activities. To undertake the activities to reduce pollution.
- (17) To do all the possible acts attempts to stop the increasing environmental hazards. To do activities like tree plantation, green bond, nursery with the help of forest ministry. To do all the activities of Public Environment Ecology, Public Cleanliness.
- (18) To establish, run and maintain water ploughs, bird seed ponds for the cows and other animals and birds at the religious places.
- (19) To do all the above related ancillary activities.





5. Number of Trustees

The number of trustees for this trust will be minimum three and maximum Nine.

6. First Trustees:

- (1) Ganpatbhai Maganlal Patel Managing Trustee
- (2) Reshma Pramodkumar Patel Trustee
- (3) Pramodkumar Amrutlal Patel Trustee
- (4) Kailasben Ganpatbhai Patel Trustee
- (5) Laljibhai Virchandbhai Patel Trustee

7. Regarding vacancy in the board of trustees:

The present first managing trustee and other first trustee will be lifetime trustees. In case if the casual vacancy is created due to death or resignation of managing trustee or other trustees, the other trustees will appoint trustee and managing trustee to fill the vacancy with majority. The appointments of these persons at casual vacancies will be permanent and lifetime. The existing trustees may appoint additional trustees within the maximum limit with majority. The trustees appointed like this will be permanent and lifetime. The resignation of managing trustee and



other trustees will be sanctioned by the remaining trustees by majority.

8. Regards to Property of Trust:

The movable and immovable property will be that which is acquired from the trustees of that time.

9. Authority and Duties of Managing Trustee:

- (1) Managing trustee will call for the meeting of the trust. He will be on president position and will conduct meeting.
- (2) Managing Trustee will be entitled to give his casting vote in case of equal votes in the meeting.
- (3) Will keep an eye on the activities of the Trust and will provide his guidance whenever needed. Will do daily activities of Trust.
- (4) He will appoint employees for the working of the Trust, will also decide their salaries, increments and leaves.
- (5) He will be having an authorized representation of the Trust with Government, semi Government and other offices of organisations and will do written communication with them.
- (6) Will issue Notice for meeting of board of trust.





- (7) Will keep the note of resolutions passed by the Trust at the meetings and will execute it.
- (8) Will give receipt for the income and vouchers for the expenses. Will keep accounting for incomings and outgoings. Will present financial accounts of the trust in the Trust General Meeting and will get the budget approved for the financial year.

11. Authority and Duties of Board of Trustee:

- (1) Will be able to distribute the immovable property of Trust, mortgage it, gift it or legally transfer it as per rules prevailing at that time.
- (2) Will invest money within the purview of applicable laws of that time.
- (3) Will be active to fulfill the objectives of Trust.
- (4) Will decide to approve the accounts and budget of the Trust after verifying the same.
- (5) All the trustees will be entitled to get the reimbursement of the expense done by him on behalf of the Trust.

12. Meeting and Quorum of Board of Trustee:

The meeting of the Board of Trustees will be called when Trustees will feel so. The Notice of such meeting will be given before seven days to the trustees. The place, time and agenda will have to



be mentioned in this Notice. The quorum of the meeting will be  $2/3^{\text{rd}}$  of the total trustees. The meeting adjourned due to lack of quorum will be held after an hour on the same day. Such meeting will not be quashed due to lack of quorum.

13. Sources of Income of Trust:

Charity, Gift, Fund, donation, contribution, help, to get grant by conducting charity show and will generate Income.

14. Resolutions and Minutes Book:

The Resolutions will be passed at the meeting by majority and will be recorded in the Minutes Book. The same will be signed by Managing Trustee and Trustees. In unusual circumstances the resolutions will also be passed through Circular.

15. Bank Account:

The Bank account will be opened with signature of managing Trustee and joint signature of other two Trustees. All the financial transactions will be done through signature of any two trustees.

16. Accounting Year:





The Accounting year for this Trust will be from 1<sup>st</sup> April to 31<sup>st</sup> March.

17. Committees:

The Board of Trustee will form any management or advisory committee whenever needed for any work of the Trust. Dissolution of these committees will also be possible. The Chairman of these committees will always be Managing Trustee.

18. Modifications:

In circumstances where there will be need of change to be done in any of the column of this Trust Deed the same can be done with the applicable provisions of Bombay Public Trust Act, 1950 with the majority votes of all the trustees.

19. Dissolution:

In circumstances where there will be need of Dissolution of Trust then it will be done with the applicable provisions of Bombay Public Trust Act, 1950. After settlement of its dues the net assets movable or immovable of the Trust shall be transferred to an association of persons or trust or society having similar objects of this Trust within the applicable provisions instead of giving it to any of the trustees, settler, donor or any other member or to the maker of the trust and the same will get dissolved. If needed the



trust can take the aid of charity commissioner and complete the procedures with his sanction.

This Deed is executed and put their signatures by both the parties in good faith in good mental state with understanding and thinking. The same is binding on all of us.


